Applicant's obligations

The qualification test applicant undertakes to:

- provide such documents and information as Kiwa Inspecta deems necessary for the performance of the work
- inform Kiwa Inspecta of any changes that may require a new assessment
- immediately discontinue references to the certificate in the event of withdrawal of the certificate
- not disclose to third parties confidential information obtained in connection with the qualification
- refrain from participating in fraudulent activities in investigations

Kiwa Inspecta's obligations

Kiwa Inspecta undertakes to:

- issue certificates in accordance with the rules of the qualification programme

Certificate

Kiwa Inspecta may immediately withdraw the certificate, if it transpires that the conditions on which the qualification or certificate is based are not met.

Reasons for withdrawal of the certificate may include:

- the certificate is used in a way for which it is not intended
- the rules on which the **qualification** is based have changed substantially
- the client has provided Kiwa Inspecta with incorrect or incomplete information in connection with the test

Withdrawal of the certificate shall be notified to the holder.
