PDF / JPEG Image / Microsoft Excel or in Microsoft Word.

Files submitted in Acrobat PDF format are preferred. In case the files are in a different format please contact Kiwa. Remark: In case of information submission, it should be send in a single file per subject, e.g. five internal photos in 1 file.
