

Radio (RF), Telecom and ITE Type Approval



Most regulatory Authorities in the world have their own national requirements in place for radio, telecom and ITE (Information Technology Equipment) devices. This means EU or FCC compliance is not necessarily sufficient to bring your products to the global market. We provide Type approval to enable market access.

Kiwa Product Compliance (formerly PCS) specializes in Radio (RF), Telecom and ITE Type Approval, in almost every country in the world and where there are requirements in place.

Any product with a communications interface or radio module will need to comply with the applicable regulations in place in all of your target markets. In the majority of countries worldwide, this means that the product will require Type Approval confirming compliance to the national regulations and standards. This is also referred to as homologation or certification.

Type Approval requirements differ from country to country. EU or FCC certification is a prerequisite for most countries however the vast majority have their own certification scheme and many have their own local testing requirement.

Leveraging a radio's modular approval?

While modular approval is generally a flexible and cost effective approach, manufacturers should take care to understand the limitations and restrictions on the leveragability of the modular approval and the additional requirements that may exist, both from an RF perspective (modular approval is not acceptable at all in some countries) and an EMC, Safety, RoHS or Energy Efficiency perspective. It is important to therefore be aware of the global requirements applicable to the host product into which the module will be installed.

Have a family of products that you wish to approve?

For families of products, it is particularly important to consider the global market that you intend to export your products into as early as possible and ideally before defining your FCC and CE test strategy.

The approach we see taken by many labs for product families while entirely suitable from an FCC / CE perspective often does not
