Location of the markings: on each pipe at a spacing of less than 2 m.

The markings shall be clear, legible and indelible affixed on the pipe.

#### **APPLICATION AND USE**

The products are intended to be applied in piping systems for the transport of drinking water and raw water till a temperature of 40°C.
