## Fitness for contact with drinking water

Sanitary tapware; single taps and mixing taps are designed for application within the following limits of use:

A static working pressure of maximum 1000 kPa and a maximum water temperature of 90 °C; The recommended limits for correct operation are a working pressure of 100 kPa up to 500 kPa and a water temperature of maximum 65 °C.

#### MARKING

The Kiwa®-mark products are marked with the word mark and watermark logo " KIWA <sup>№</sup> " Place of the mark: on the body

Compulsory specifications:

- · Name or mark of manufacturer, on the body;
- · Indication for temperature selection, on the handle;
- The acoustic group, if classified, on the body;
- · The flow rate class, on the body.

#### Method of marking:

- · Non-erasable;
- Visible after assembly.
