The single taps and combination taps are designed for application within the following limits of use: a static working pressure of maximum 1000 kPa and a maximum water temperature of 90°C. The recommended limits for correct operation are a working pressure of 100 kPa up to 500 kPa and a water temperature of maximum 65°C.

MARKING

The Kiwa®-mark products are marked with the wordmark "KIWA" together with the Watermark logo 

Place of the mark: on the body.

Compulsory specifications:

- name or mark of the manufacturer, on the body;
- indication of the acoustic group, if classified: on the body;
- indication of the flow rate class, if classified: on the body.

Method of marking:

- non-erasable;
- visible after assembly.
