Fitness for contact with drinking water

MARKING

The minimum required marking on the pipes shall be:

- KIWA \$\iiii + \text{class 2/ 10, 8 or 6 bar;}
- manufacturer's name, trade name, system name or certificate number of accompanying technical approval (system)certificate;
- material identification: PE-Xc;
- the build up of the pipe: PE-Xc/EVOH (AI)/PE-Xc (for 5 layer pipes) or PE-Xc (for 1 layer pipes);
- nominal outside diameter and nominal wall thickness in mm;
- production code.

Location of the marks: on every pipe at intervals of not more than 2 m.

The realization of the marks is as follows: durable and indelible.
