APPLICATION AND USE

An integrated Watermeter Connection Unit is designed to make the connection between the service pipe and the tap water installation and to connect watermeters according to BRL-K618 with a nominal measured capacity up to Qn 2,5. The Units are intended for use in drinking water installations with a maximum pressure of 1000kPa and a water temperature up to 20 °C.
