

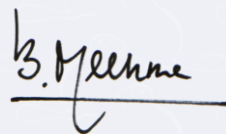

APPLICATION AND USE

The sanitary tapware "mechanical mixers" are designed for drinking water installations with a maximum working pressure of 1000 kPa and a maximum water temperature of 90°C.

The recommended limits for correct operation are a working pressure of 100 kPa up to 500 kPa and a watertemperature of maximum 65°C.

MARKING

The products are marked with the wordmark “KIWA”.

Place of the mark:

- on the body or control handle.

Additional compulsory specifications:

- name or mark of manufacturer: on the control handle;
- indication on choice of temperature on the controlhandle;
- identification of the accoustic group if classified, on the body;
- identification of the flow resistance class, on the body.
