Application and use

The WC-pans delivered under this certificate in combination with flushing cisterns and/or pressure flush valves are intended for use as sanitary appliances, connected to drinking water installations with a water temperature of 30 °C maximum.

MARKING

The Kiwa®-mark products are marked with the word mark "KIWA". On the WC-pan this word mark shall be followed by

- the number 6, 7.5 or 9, indicating the flushing volume;
For WC-pans approved at a nominal flush of 4 or/and 5 litres, only the wordmark "Kiwa" is permitted.
- the letter A and or C which indicates the type of flushing device to be connected:
 - **A** intended for connection with a cistern (or concealed cistern).
 - **C** intended for connection with a pressure flush valve.

The WC-pan is marked as follows:

"KIWA-6-A "

By this marking it is given that the WC-pan is Kiwa certified and intended for connection to a (concealed) flushing cistern. The minimum water volume required to perform a full flush amounts 6 ± 0.2 litres.

Place of the mark:

- on the WC-pans between the attachment holes of the lavatory seat or on one of the sides of the flushing rim.

Compulsory specifications:

name or mark of the manufacturer

- on the WC-pans between the attachment holes of the lavatory seat or on one of the sides of the flushing rim;
- additional markings as specified in the European Standard EN997.

Method of marking:

- non-erasable;
- visible after assembly.
