This certificate covers the product 'Perma Treat® PC-1638T'. The product is utilized as antiscalant for reverse osmosis installations.

PRODUCT REQUIREMENTS

The product as described in this certificate complies with BRL K15003, including the requirements as specified in NEN-EN 15040: Chemicals used for treatment of water intended for human consumption – Antiscalants for membranes-Phosphonic acids and salts.

FITNESS FOR CONTACT WITH DRINKING WATER
