

PRODUCT SPECIFICATION

This certificate covers the oxidant 'HydroXan®20' used to clean disconnected drinking water installations and to regenerate active carbon and filter media.

APPROVAL

The products are approved on the basis of the requirements set in the "Regeling materialen en chemicaliën drink- en warm tapwatervoorziening" (Regulation materials and chemicals for drinking water and warm tap water supply; published in the Government Gazette).

CRITERIA HYGIENIC ASPECTS

The product certification is based on two main criteria. It should permanently comply with the:

- product recipe approved during the assessment procedure. This recipe is not to be changed without prior approval by Kiwa following the Kiwa approval procedure related to the hygienic aspects.
- specific product requirements (see "PRODUCT REQUIREMENTS HYGIENIC ASPECTS").

PRODUCT REQUIREMENTS HYGIENIC ASPECTS

For this product no specific product requirements are applicable.

APPLICATION AND USE

The following conditions apply to the use of 'HydroXan®20':

- HydroXan®20 is used to clean disconnected drinking water installations and regenerate active carbon and filter media.
- After use of HydroXan®20, the cleaned/regenerated surface has to be thoroughly rinsed with water before re-entering the operational state.
- HydroXan®20 shall not be used as a biocide, nor as a precursor for making a biocide.

MARKING
