- Word mark **Kiwa** or KK \*;
- manufacture's name, trade name;
- nominal outside diameter in mm of the pipe;
- production date or production code\*.

Marking with BRL-K 506 is optional.

\* For small fittings marking with KK only is allowed. These indications may, if not otherwise possible, be provided together with the smallest packaging unit.

The products are designated for the fastening of cold- and hot water copper or plastic pipes.
