APPLICATION AND USE

Shower heads and hand showers for sanitary tapware according to EN 1112 are intended for use in drinking water systems within the following limits: a dynamic pressure of 50 kPa to 500 kPa and a maximum temperature of 70°C. The recommended limits for correct operation are: a dynamic pressure of 100 kPa to 300 kPa and a maximum temperature of 42°C.
