

DECLARATION of INTEREST

The Group's mission is to give life to an organization able to generate trust in its activities and therefore providing useful services for business, in compliance with the principles of independence, impartiality and competence.

The maximum commitment that we have undertaken to ourselves and that we renew on an ongoing basis, is to operate as a competent and independent body, without involvement in any activity that could compromise our impartiality. The decisions and relationships connected to our operational activities, such as certification, testing and inspection, are provided without any external influence.

The Management Team and all Kiwa Group employees understand the importance of objectivity and impartiality in carrying out certification, testing and inspection activities.

Our Code of Ethics, is shared and accepted by all employees (including external collaborators) who work for us and with us in the provision of conformity assessment services.

This commitment translates into a series of preventive and corrective actions and continuous improvement that are implemented by Kiwa Group staff and periodically verified through internal auditing processes and periodic management reviews to ensure their effectiveness. We regularly analyse our activities, in order to preserve our objectivity and impartiality, identifying any eventual conflicts of interest and managing them in an adequate manner.

Moreover, our activities are verified by regulatory bodies, as well as several accreditation bodies, that as third party with respect to Kiwa, in turn guarantee an impartial and independent evaluation.
